

Privacy Policy

This privacy policy applies between you, the User of this website and K&O Construction, the owner and provider of this website. K&O Construction takes the privacy of your information very seriously. This privacy policy applies to our use of any and all data collected by us or provided by you in relation to your use of this website.

Please read this privacy policy carefully.

Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	Collectively all information that you submit to K&O Construction via this website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	A small text file placed on your computer by this website when you visit certain parts of the site and/or when you use certain features of the website. Details of the cookies used by this website are set out in the clause below (Cookies) ;
Data Protection Laws	Any applicable law relating to the processing of personal data, including but not limited to the Directive 96/46/EC (Data Protection Directive) or the GDPR, and any national implementing laws, regulation and secondary legislation, for as long as the GDPR is effective in the UK;
GDPR	The General Data Protection Regulation (EU) 2016/679;

2. In this privacy policy, unless the context requires a different interpretation:
 - a. The singular includes the plural and vice versa.
 - b. References to sub-clauses, clauses, schedules or appendices of this privacy policy.
 - c. A reference to a person includes firms, companies, government entities, trusts and partnerships.
 - d. "Including" is understood to mean "including without limitation".
 - e. Reference to any statutory provision includes any modification or amendment of it.
 - f. The heading and sub-heading do not form part of this privacy policy.

Scope of this privacy policy

3. This privacy policy applies only to the actions of K&O Construction and users with respect to the website. It does not extend to any websites that can be accessed from this website including, but not limited to, any links we may provide to social media websites.
4. For purpose of the applicable Data Protection Laws, K&O Construction is the "data controller". This means that K&O Construction determines the purposes for which, and the manner in which your data is processed.

Data Collected

5. We may collect the following data, which includes personal data from you:

- a. Name.
- b. Contact information such as email address and telephone numbers.
- c. Financial information such as budgets, value of property, cost of project.
- d. Details of their property; in each case, in accordance with this privacy policy.

How we collect data

6. We collect data in the following ways:
 - a. Data is given to us by you.
 - b. Data is collected automatically.

Data that is given to us by you

7. K&O Construction will collect your data in a number of different ways, for example:
 - a. When you contact us through the website, by telephone, by post, e-mail or through any other means;
 - b. When you complete surveys that we use for research purposes (although you are not obliged to respond to them).
 - c. When you enter a competition or promotion through a social media channel.
 - d. When you make payments to us, through this website or otherwise;
 - e. When you use our services; in accordance with this privacy policy.

Data that is collected automatically

8. To the extent that you access the website, we will collect your data automatically, for example;
 - a. We automatically collect some information about your visit to the website. Our use of Data

9. Any or all of the above data may be required by us from time to time in order to provide you with the best possible service and experience when using our website. Specifically, data may be used by us for the following reasons;
 - a. Internal record keeping.
 - b. Improvement of our products/services.
 - c. So staff know the location of the job on which they will be working and so materials to complete the projects can be delivered to the correct places; in each case, in accordance with this privacy policy.
10. We may use your data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your Rights" below).

Who we share data with

11. We may share your data with the following groups of people for the following reasons:
 - a. Our employees, agents and/or professional advisors – so staff know the location of the job on which they will be working and so materials to complete the projects can be delivered to the correct places.
 - b. Relevant authorities – planning permission for certain jobs; in each case, in accordance with privacy policy.

Keeping data secure

12. We will use technical and organisational measures to safeguard your data, for example:

- a. Access to your account is controlled by a password and user name that is unique to you.
 - b. We store your data on secure servers.
 - c. Payment details are encrypted using SSL technology (typically you will see a lock or green address bar (or both) in your browser when we use this technology).

Data retention

15. Unless a longer retention period is required or permitted by law, we will only hold your data on our period necessary to fulfil the purposes outlined in this privacy policy or until you request that the data be deleted.
16. Even if we delete your data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

17. You have the following rights in relation to your data:
 - a. **Right to access** – the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge for this, unless your request is "manifestly unfounded or excessive". Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
 - b. **Right to correct** - the right to have your data rectified if it is inaccurate or incomplete.

- c. **Right to erase** - the right to request that we delete or remove your data from our systems.
 - d. **Right to restrict our use of your data** - the right to "block" us from using your data or limit the way in which we can use it.
 - e. **Right to data portability** – the right to request that we move, copy or transfer your data.
 - f. **Right to object** – the right to object to our use of your data including where we use it for our legitimate interests.

Changes of business ownership and control

22. K&O Construction may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of K&O Construction. Data provided by users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under

the terms of this privacy policy, be permitted to use the data for the purposes for which it was originally supplied to us.

- 23. We may also disclose data to a prospective purchaser of our business or any part of it.
- 24. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

Cookies

- 25. This website may place and access certain cookies on your computer. K&O Construction uses cookies to improve your experience of using the website. K&O Construction has carefully chosen these Cookies and has taken steps to ensure that your privacy is protected and respected at all times.
